As an arts organisation offering events and projects for people living with memory loss, Resonate Arts needs to hold and process information about people on our data base. Some of this information is personal data; this means it can be used to identify you. The law gives you rights around what happens to this personal information.

This Privacy Notice tells you who we are, what information we will collect, how we will use it, how we will keep it and who we will share it with.

\* Some of the above information that we need to collect is sensitive in nature i.e. it is considered to be in a special category – as it might include your health and support needs (physical/ mental health issues or mobility problems) and your ethnic origin

# Keeping your information

We will keep this information whilst you remain on our mailing list and for a year afterwards. We will store your information securely in computer systems or in certain circumstances in manual files in a locked drawer. We will dispose securely of all information when it is no longer necessary.

# Who we will share your information with

- Other health or arts agencies we refer you to with your consent
- Details about your preferences and needs only, to artists and volunteers working on the project to help them prepare the session/event
- We may share your information with your emergency contact if we think this is important to you, and in all cases with your permission where possible
- We may share your information with the police, fire or ambulance services in an emergency in order to help you

We only share the minimum amount of personal data necessary to enable us to fulfil our legal obligations.

We will not sell your personal data.

We never share information with marketing or insurance companies.

# Lawful basis for collecting and processing your information

# **Resonate** Arts

The law says that we have to meet a legal condition under GDPR and the Data Protection Act 2018 before we can process (including sharing) your personal data. The conditions which apply for the personal data that we process are:

**Consent:** We ask for your explicit consent to process information about your health so that we can tailor our services to meet your needs.

**Necessary to protect your vital interests:** for example, to contact a relative if you have an accident.

**To monitor equality of opportunity:** this allows us to monitor diversity statistics about the ethnicity and disability to meet our obligations under equality and diversity law.

We do not share, or transfer, your personal information to any third countries outside of Europe or those without adequate levels of protection for the rights and freedoms of individuals over their personal data.

# Your rights

You have the following rights set out in law concerning your personal information – the right to:

- be informed about how we process your personal data (which is why we have developed this Privacy Notice);
- have access to a copy of the personal information we collect and keep (known as a Subject Access Request);
- have inaccurate or incomplete personal data rectified;
- restrict processing of your personal data in certain circumstances, for example when you are contesting the accuracy or you object to the processing;
- object to processing for direct marketing or for the company's legitimate interests or performance of a task in the public interest, or for purposes of scientific/historical research and statistics
- have your personal data erased in certain circumstances where there is no compelling reason to continue processing it;
- object to automated decision making that would affect you significantly, in certain circumstances;
- claim compensation for damages caused by a breach of the Data Protection Act (this can only be done via the Courts); and
- at any time, withdraw your consent for us to use or share your special category personal information where you have previously given us your consent for this.
- Opt-out of sharing personal data for the purpose of improving care or services under the National Data Opt-out policy.



# National Data Opt-out

Resonate Arts works in the health and care system to improve health and well-being care for individuals and the public.

As part of our services, we disclose anonymised and aggregated information to commissioning bodies and funders for monitoring and evaluation purposes only. In these cases, individuals cannot be identified, and confidential information isn't necessary.

We only share personal information that identifies you, and only as necessary, with other **care providers** in order for you to be supported and/or cared for well.

We can sometimes be asked to provide personal or confidential information for the purpose of planning or improving health and care services for you and others. We can only do this where this is allowed in law. This usually means we invite Resonate Arts participants to specific consultation events for this purpose.

However, if you want to ensure your personal confidential information is never used in this way – for the purpose of planning or improving health care services for you and others, by Resonate Arts or any other organisation, you are legally entitled to register to opt-out.
